(the "Company") equity compensation programs.

3. The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$17.29 to \$17.57. The Reporting Person undertakes to provide the Company, any security holder of the Company, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the range set forth in this footnote.
4. Each Restricted Stock Unit represents a contingent right to receive one share of the Company's Class A Common Stock.
5. On January 2, 2021, the Reporting Person was granted 2,553 Restricted Stock Units, half of which vested in four equal quarterly installments beginning on March 31, 2021, and the remainder vested in three equal annual installments beginning on January 2, 2023.
6. On January 3, 2022, the Reporting Person was granted 7,719 Restricted Stock Units, half of which vested in four equal quarterly installments beginning on March 31, 2022, and the remainder vest in three equal annual installments beginning on January 3, 2024.
