## **Explanation of Responses:**

- 1. Each Restricted Stock Unit represents a contingent right to receive one share of the Company's Class A Common Stock.
- 2. On January 2, 2019, the Reporting Person was granted 11,654 Restricted Stock Units. One half of the Restricted Stock Units vest in four equal quarterly installments beginning on March 31, 2019. The remaining Restricted Stock Units vest in three equal annual installments beginning on January 2, 2021.
- 3. On January 2, 2019, the Reporting Person was granted 2,913 Restricted Stock which vest in four equal annual installments beginning on January 2, 2020.
- 4. One half of the Restricted Stock Units vest in four equal quarterly installments beginning on March 31, 2020. The remaining Restricted Stock Units vest in three equal annual installments beginning on January 2, 2022.
- 5. The Restricted Stock Units vest in four equal annual installments beginning on January 2, 2021.
